### Certification Form

To the best of your knowledge, complete the two-page Certification Form.



Every day we help businesses take hazardous materials out of the landfill by encouraging safe and smart disposition of hazardous materials. It's easy to participate requiring only a few short steps prior to your first visit.

Let us help you protect the environment

### Registration

Businesses must complete a registration/certification form. This form will certify the business is a Very Small Quantity Generator (VSQG) and register it with the Cedar Rapids Linn County Solid Waste Agency.

Agency staff will review the completed form and contact the business to set up a delivery or pick-up of the hazardous materials.

### Shipping Papers

Businesses must complete the shipping paper, including the name of the chemicals, the quantity of material and the number of containers. Additionally, this form must include an emergency contact person with a phone number, signatures of the business representative and the driver.

The Agency is available to pick up hazardous materials. If this service is needed, please indicate with the shipping paper.

### Drop off or Pick up Appointments

VSQG participants must make an appointment for hazardous waste disposal regardless of whether the material is dropped off at the Agency or picked up by the Agency. Appointments are made during normal business hours Monday-Friday.

### Billing

Payment must be made at the time of delivery in the form of cash, credit card, business check or through a pre-approved charge account with the Agency.

## Certification Form (By law, this form must be kept on file)

I certify that I am a generator of hazardous waste within the State of Iowa and that because of the small volume of hazardous waste generated and/or stored, I qualify for very small quantity generator status.

I understand that to qualify for very small quantity generator status, I must meet both of the following conditions (as defined by 40 CFR Section 261.5):

- » Generate less than 1kg/month (2.2 pounds) of acute hazardous waste, and never store more than this amount on site at any time; and

- » Generate less than 100 kg/month (220 pounds) of all other hazardous waste, and never store more than 1,000kg (2,200 pounds) on the site at any time.

I further understand that if, in the future, I exceed the quantity limitations described above, I will become subject to additional regulation as a hazardous waste generator and will no longer be eligible to participate in this type of collection program.

I certify that I have the right to make these statements on behalf of my farm or business.
