Battery Recycling – it's a BIG DEAL!

When it comes time to get rid of an old battery, please remember, they do not go in the garbage! Many types of batteries can cause fires if they end up in the landfill. When batteries get runover by Agency bulldozers and compactors, they can crack and get air inside which causes a reaction sparking a fire.

To make battery recycling safe and easy, the Solid Waste Agency accepts all batteries for no charge from Linn County residents. Bring them to 1954 County

Home Road, Marion, and drop off inside the Resource Recovery building. All batteries are accepted: lithium, lithium-ion, alkaline, button batteries from watches, power tool batteries, car batteries, and more.

Have electronics with embedded batteries that cannot be removed? These can also be dropped off as part of the electronics recycling program. Again, no charge for Linn County residents to drop off electronics or batteries generated from your home.

The Solid Waste Agency will soon be offering **more battery recycling drop-off locations** around Linn County to make recycling even easier. Check the Agency's website, www.solidwasteagency.org for updates soon!

Thanks for helping keep Linn County safe and the landfill free from battery fires. **Take charge and recycle right!**

WHAT TO DO WITH BATTERIES

HOW TO RECYCLE

- 1** PLACE ALL BATTERIES IN A BOX OR BAG
- 2** DROP OFF AT COLLECTION SITE

Batteries should NEVER be placed in your recycling bin or household trash.

COLLECT ALL BATTERIES FOR RECYCLING

AA, AAA, C, D AND 9-VOLT BATTERIES
These household batteries may be labeled alkaline or rechargeable.

LITHIUM BATTERIES
Lithium batteries can still spark a fire even if they cannot power their equipment.
Built-in batteries? If the batteries cannot be removed, bring in the entire product for proper disposal.

SMALL, SEALED, LEAD-ACID BATTERIES
These batteries can be recharged by a household outlet. They contain hazardous chemicals that could harm family and pets or contaminate land and waterways if disposed of improperly.

Found in battery-powered scooters, remote control cars and many other toys and products.

O-C-C! Only Clean Cardboard

Cardboard is banned from the landfill.

But the good news is, it can be RECYCLED FOR FREE at the Solid Waste Agency. If you are going to drop off cardboard inside the Resource Recovery building at 1954 County Home Road, Marion, remember those cardboard boxes need to be **empty, clean, and dry!**

Empty means absolutely no Styrofoam, no plastic wrap, and especially no wood. Some cardboard boxes used for delivery have wood framing glued to the inside of the box. If that is not removed, it can pose a serious injury risk to Agency staff when they put the cardboard boxes into a baler. Please help keep staff safe and recycle right. Make sure your cardboard is **OCC: Only Clean Cardboard!**

Winter Hours

During winter months, the number of customers using Solid Waste Agency services decreases greatly. Reducing the Agency's hours of operation over winter saves in fuel usage and wear on heavy equipment.

Winter Hours – Marion

Starting Monday, December 1, 2025 the Solid Waste Agency Landfill and Resource Recovery Building (located at 1954 County Home Road, Marion) will operate under winter hours:

Monday - Friday 7 a.m. - 4 p.m.

Saturday* 8 a.m. - 12 p.m.

**Appointment or commercial account is required to visit on a Saturday, even for recycling-only loads. Make your appointment at solidwasteagency.org.*

Holiday Recycling Notes!

The holiday season is getting closer. Whether you are making room for new stuff or getting rid of unwanted items, here is what you need to know about recycling and disposal.

What To Do With Unwanted TVs and Monitors

Recycle at the Solid Waste Agency, 1954 County Home Road, Marion, inside the Resource Recovery building. Fees are \$15 each (regardless of size and weight) or \$0.25 per pound for loads with 5 or more units.

What To Do With Electronics

Electronics such as DVD players, VCRs, stereos, and more (see above for TVs and monitors) can be recycled in the Resource Recovery building at the Solid Waste Agency Marion facility. There is no charge for residential-size loads; \$0.25 per pound for bulk/commercial-size loads.

What To Do With Christmas Lights

Recycle for free in the Resource Recovery building at the Solid Waste Agency Marion facility as part of the electronics recycling program. *They CANNOT be recycled curbside in any community.*

What To Do With Wrapping Paper

Throw away. It cannot be recycled because of the lack of good quality fiber and variety of shiny or foil coatings. Even paper that claims to be "recyclable" should be thrown away so it doesn't contaminate the rest of the recyclables! Consider using reusable gift bags instead!

What To Do With Plastic, Cardboard and Paper

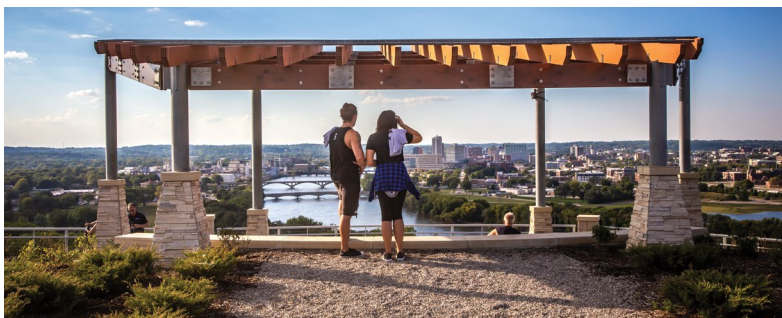
Can be recycled for free in the Resource Recovery building at the Solid Waste Agency Marion facility.

What To Do With Batteries

Recycle ALL batteries – lithium, rechargeable, lead acid, alkaline, and automotive batteries. These include batteries from hearing aids, watches, power tools, and cars. Linn County residents can drop batteries off for no charge at the Solid Waste Agency Marion facility, 1954 County Home Road, inside the Resource Recovery building.

What To Do With Christmas Trees

First, check with your hauler to see if they will collect Christmas trees curbside. They may have rules for disposal. Trees are accepted at the Solid Waste Agency, 2250 A Street SW location only for a \$15 flat fee. *Flocked trees are considered a garbage item. Most communities have requirements for how they can be thrown away. Check with your hauler.*



Mount Trashmore is Closed for the Season; Reopens Spring 2026

The Mount Trashmore trails and overlook are closed for the season. More than 31,000 people visited in 2025! That is a new record! Trashmore Trails will be back and better than ever next spring when the weather allows!

A big congratulations to all Mount Trashmore Challenge participants. Organized by the Czech Village New Bohemia Main Street District, participants signed up to ascend Trashmore 140 times, the equivalent of scaling Mount Everest. More than 350 signed up for the challenge and around 100 of those participants completed the challenge this year. Great work!



CD, DVD, VHS, & Cassette Tape Recycling Available Now!

When is the last time you popped a VHS tape into your VCR or had to flip a cassette over in your boombox? You probably don't have a VCR or boombox anymore, or maybe not a DVD or CD player either.

If you have unwanted or unused **VHS tapes, CDs, cassettes, or DVDs**, you can now recycle them and their cases! They are all accepted for no charge in the Resource Recovery building at 1954 County Home Road, Marion. The materials collected at the Solid Waste Agency are taken by Goodwill of the Heartland and processed through their partnership with Dell Reconnect. This keeps them out of the landfill, helping preserve space for non-recyclable materials.

Garbage (Landfill)

\$50 per ton \$22 minimum

- Flat Rates for Personal Vehicles
Cars - \$12/vehicle
SUVs, Crossovers, Wagons, Minivans - \$15/vehicle
Pickup Trucks, Full-Size Vans - \$22/vehicle
- Box Trucks, Cargo Vans - \$50 minimum; will be weighed, includes U-Haul, Ryder, Penske trucks.
- Bulky Loads - \$80 per ton, see list on website
- Mattresses - \$20 ea. (separate charge from garbage tonnage/flat rates)
- Loads may be weighed at scale house discretion.
- Tipping fee doubles for loads containing recyclable cardboard; fines issued for other banned materials.
- All loads must be covered and secured. Fine for noncompliance: \$25 residential/\$100 commercial.
- Payment due at time of service – cash, credit/debit card, or business check.
- **Yard waste, brush & tree debris NOT accepted at this location.**

Hazardous Materials Drop-Off

FREE to Linn County Residents

(Businesses call for pricing) Drop off items in the Resource Recovery Building to safely dispose of hazardous materials such as paint and lawn chemicals. See website for list of accepted items.

FREE Paint, Cleaners, Etc.

Pick Up for FREE

Hazardous materials received that can still be used are available “as is.” Inventory changes daily.

Agency staff are not authorized to help with unloading.

- No longer accepts loads of tree debris brought in by semi-trailers, side-dump trailers, dump trucks, or other large equipment used in land-clearing.
- Accepts commercial loads, all trailer loads, and any size residential loads.
- Brush, tree limbs, stumps less than 12" diameter, plant/grass clippings, leaves, Christmas trees.
